

## CLASSIC CABINET FRONTS

CLASSIC CABINET FRONTS is a sole proprietor business. It has been owned for 23 years by Brad and Stephenie Anderson, and employs one full-time employee, Craig Madsen, who has been the Installer/Quality Manager the entire time. CLASSIC CABINET FRONTS is legally licensed to have employees.

### Costs

Some refacers charge by the number of doors. CLASSIC CABINET FRONTS charges by how much square or linear feet of material your kitchen or bathroom will use and how large or complicated the job is.

During the past 23 years of doing strictly refacing, the average CLASSIC CABINET FRONTS kitchen refacing has run about \$4000-4200, which is about 1/3 the cost incurred when a national chain store does the same job.

### Refacing versus Replacing

Refacing by CLASSIC CABINET FRONTS runs about 40-60% of the cost of new, custom-built, quality cabinets. It will not save you a dime if new modular, particle board cabinets are purchased from a "big box" store.

Refacing is not for everyone. If your cabinets are not structurally sound or if you want to make major layout changes, then cabinet refacing might not be the thing to do. However, if your cabinets are structurally sound and just a few changes are wanted (add one or two cabinets, modify 2-3 cabinets), then refacing by CLASSIC CABINET FRONTS makes sense.
